

# VISA APPLICATION PROCEDURES

READ IMMEDIATELY

\*YOU are responsible for obtaining your own Spanish Student Visa\*

You must **mail OR hand-deliver** your student visa application materials to the Spanish Consulate in NYC!

Carefully read through this entire document NOW!

You must submit your student visa application materials to the Consulate **at least 4-7 weeks prior to your departure date**. Therefore, **Spring 2016** students should submit their application materials to the Consulate no later than **November 25, 2015**.

**\*Please Keep in Mind\***

The Consulates General of Spain are not affiliated with the University at Albany, SUNY. They are entities of the Spanish government that are responsible for issuing visas and performing other functions. Please keep in mind that Consulates independently create their requirements for obtaining a student visa and requirements may sometimes change without notice. Therefore, please be sure to check the website of the Spanish Consulate before applying for your student visa to be sure that the rules have not changed.

**General FAQs:**

**Q: What is a visa?**

A: It is an official stamp issued by the Spanish government that is affixed to a page inside your passport before you depart the United States. It must be presented to immigration control when you arrive in Spain.

**Q: Why is a visa necessary?**

A: Visitors staying in Spain for more than 90 days require a visa (depending on nationality – this is explained in the next section). Spanish immigration control is wary of individuals staying in Spain for more than 90 days without a valid and specific reason. A visa lets the Spanish authorities know that you are there for valid reasons. Further, visa processes are based on reciprocity. Since the U.S. requires citizens of most nations worldwide to obtain a visa in order to enter the U.S., many nations (such as Spain) have similar requirements for U.S. citizens entering Spain.

**Q: Does every student on UAlbany's Spain Semester programs need a visa?**

A: It depends!

- If you are a U.S. citizen: **Yes**, you will need to apply for a student visa.
- If you are a citizen of the European Union: No, you do not need a student visa to enter Spain. You may enter with your valid E.U. passport.
- If you are not a citizen of the U.S. or the E.U.: Maybe. You should check with the Spanish Embassy at <http://www.spainemb.org> to see if your nationality requires a visa to study in Spain for more than 90 days.

**Q: Who will issue my visa?**

A: You must apply for your visa through a General Consulate of Spain. Don't send your visa application to UAlbany Office of Education Abroad!! This will delay the entire process, as **ONLY** a Spanish Consulate can issue the visa. There are several Spanish Consulate offices in the

United States: Boston, Chicago, Houston, Los Angeles, Miami, New Orleans, New York, and San Francisco.

You should apply through the Consulate of Spain in New York City if:

- You are a full-time student at a college/university located in New York, Connecticut, Delaware, Pennsylvania, or New Jersey.
- Your permanent address is in New York, Connecticut, Delaware, Pennsylvania, or New Jersey.

If you do not meet the criteria to apply at the Consulate of Spain in New York, please scroll down to the end of this document to see the list of Spanish Consulates and their jurisdictions. Keep in mind that **visa application requirements and procedures may vary among the different Consulates**. READ your Consulate's website and follow their guidelines for applying for a student visa – they could be different from what is explained below!!

The decision to issue your visa rests solely with the Consulate. UAlbany cannot change visa requirements nor does it help if we call Consulates on your behalf.

**Q: What kind of visa should you apply for?**

A: 180-day student visa (recommended for students studying in Spain for a single semester):

- Valid for six months
- Allows multiple entries (which allows you to travel in and out of Spain)
- Does not require you to obtain a 'Spanish Residency Card' upon arrival in Spain
- **Cannot be extended** (meaning if you decide to extend your study abroad period in Spain for a second semester, you will have to go back to the U.S. and start the visa process again)

More than 180-day visa (recommended for academic year students):

- Valid for three months
- Requires you to obtain a Spanish Residency Card upon arrival in Spain
- Recommended for academic year students or single semester students who have even the slightest inclination of extending their stay.

The main difference between these two types of visas is that academic year students are required to obtain a **Spanish Residency Card** in order to legally stay in Spain for a full academic year. Your Program Director in Spain will assist you with this process.

**\*Please note\*** If you are planning to stay in Spain for the **academic year** (or even considering it) please alert UAlbany right away so that we can include the academic year dates in your visa letter for the Consulate. This will allow you to get a visa that will permit you to stay for both semesters.

**Q: When should you submit your application?**

A: The Spanish Consulate in New York requires at least four to seven (4-7) weeks to process visa applications. Allow yourself as much time as possible, which is why we recommend submitting your application 7 weeks in advance, even though the Consulate's website states that 4 weeks is adequate. If you do not submit your application at least four to seven weeks in advance, you may not get your visa in time for your departure date. In fact, the Consulate may not even accept your visa application if submitted less than 4 weeks prior to departure. **The Consulate will keep your passport while they are processing your visa.**

On the other hand, the Spanish Consulate in New York will not accept an application more than four months in advance of your departure date for Spain.

Consulates in other cities and visa processing for non-U.S. citizens may have different timelines. Be sure to check with your particular Consulate.

## Finally: How, exactly, do I apply for a visa?

### 1. Get your passport.

- If you don't have a passport that is valid for at least 6 months beyond your intended departure date *from* Spain, apply for a new passport today! Visit <http://travel.state.gov> for more information.
- Keep in mind that you can only apply for your visa with the passport you will actually be traveling on. Apply early! If necessary, select expedited processing (usually requires about 2 weeks).

### 2. Gather your student visa application materials.

- Use the checklist below as a guide to compile your visa application materials. Remember, requirements may vary based on your country of citizenship and which Spanish Consulate you apply through.

### You must submit ALL of the following ORIGINAL items to the Spanish Consulate (either by mail OR hand-delivered):

- *National Visa Application form* (please refer to the guide beginning on page 7). Download the application form from the Spanish Consulate's website – [click here](#) for a direct link.
- *1 recent passport-sized photo* (white background). Official 2x2 passport-quality photos only! No photocopies or photos from home printers accepted. Write your full name on the back and attach the photo to your National Visa Application.
- Your **actual** Passport (*not a just a copy*). The passport must be valid for at least 6 months beyond your intended departure date from Spain and have at least one blank page to affix the visa. Make sure you've signed your passport! Include your green card if you have one. NOTE: The Consulate will keep your passport for 4-7 weeks while they are processing your visa.
- A **photocopy** of ONE of the following: your U.S. driver's license OR your school student ID card. This requirement is intended as proof that you either reside in OR attend school in one of the states for which the New York City Consulate is responsible.
- The official Visa Letter from UAlbany to serve as proof of admission to a Spanish academic center as a full-time student and guarantee of payment of your tuition, room

and board. Bring along your current transcripts as well. NOTE ⇒ UAlbany includes this visa letter with your acceptance packet materials.

**IMPORTANT NOTE:** If you are making your own housing arrangements instead of living with a host family provided by your program, you may be required to supply additional proof of financial support for personal living expenses in Spain. Contact UAlbany for details.

- *Proof of **Travel Health Insurance*** with a minimum coverage of 30,000 euros (or the equivalent in dollars) during the planned period of stay in Spain. UAlbany will certify in your visa letter that you have the SUNY health insurance policy and repatriation coverage (through SUNY HTH Health & Medivac Insurance). You will be automatically enrolled in and billed for this insurance policy by UAlbany along with your other study abroad charges.
- *A notarized letter from your parents or legal guardians assuming full financial responsibility for at least \$700 per month for room and board. **Suggested wording of the letter:** "I hereby certify that I'm the (father/mother/other) of (...), will support him/her with a monthly allowance of at least \$700 while he/she is in Spain and that I'm financially responsible for any emergency that may arise". Note: your legal guardian must sign and date this letter and have it **notarized** by a public official.*
- *"Money-Order" to pay the **non-refundable** visa fee of **\$160** for U.S. citizens payable to the **Consulate General of Spain**. **The Consulate will only accept money orders issued by the U.S. Postal Service** – so you must go to a post office to purchase one. No personal checks or cash accepted! Fees are subject to change; [click here](#) to check the Consulate's web site before applying.*
- *If you want your visa mailed (as opposed to going back to the Consulate to pick it up in person), you must provide a **self-addressed and pre-paid UPS (United Parcel Service)** envelope label from UPS and submit it to the Consulate with your other materials. You must create a shipment on-line at [www.ups.com](http://www.ups.com) and print the label digitally. Hand-written pre-paid envelopes will not be accepted. The Spanish Consulate can provide the UPS *envelope* as long as you provide the printed pre-paid shipping label. **The Spanish Consulate will NOT accept any other type of courier or messenger service.** Note: this envelope will be used by the Consulate to mail your visa and passport back to you. The mailing label must include the Spanish Consulate's address as the SENDER and YOUR address (where you can receive mail prior to your departure) as the RECIPIENT. Tracking of mailed items is the responsibility of the applicant.*

**Make 2 photocopies of each document (original + a copy for the Consulate, plus a copy for your records)**

**ADDITIONAL REQUIREMENTS FOR **ACADEMIC YEAR** (Fall + Spring) STUDENTS ONLY!!**

A complete application for an academic year visa consists of all the items listed above **PLUS** the following additional documents:

➤ **APUNE Health Assessment form:** This APUNE form is required in addition to the standard SUNY health form (from your on-line study abroad application.) [Click here](#) to download the APUNE Health form.

➤ **Copy of F.B.I. or State Police Background Check with Apostille certification\*:** Please start working on this immediately, as it takes more than three months to get your F.B.I. record back after you submit your fingerprints. *Please keep in mind that the F.B.I. record can NOT be more than 3 months old when you apply for your student visa at the Spanish Consulate.*

Depending on the state in which you live, getting a State Police background check and the corresponding State-level Apostille may be quicker.

\* An apostille is a certification that a document has been 'legalized' or 'authenticated' by the issuing agency through a process in which various seals are placed on the document.

NOTE: At the time you submit your F.B.I. record request documents to the F.B.I., you must also include an additional cover letter to request that the F.B.I. place the appropriate seals on the ID record. This is required by the U.S. Department of State Authentications Office, which is the office to which you must send your FBI ID record in order to have the Apostille attached.

**Authentication of FBI Certificates of Lack of a Criminal Record:** the FBI's CJIS Division will authenticate U.S. Department of Justice Order 556-73 fingerprint search results for international requests by placing the FBI seal and signature of a Division official on the results, if requested at the time of submission. Documents prepared in this manner may then be sent to the [U.S. Department of State Authentications Office](#) by the requestor to be authenticated if necessary. Please be sure to indicate the country in which the document is to be used. See the FBI FAQ on this subject (link below).

**Guide for Completing the [National Visa Application form](#):**

- 1-3: your own name – ‘surname/family name’ is your last name
- 7: ‘nationality’ refers to your country of citizenship, not your ethnic heritage
- 10: leave blank unless you’re under 18
- 11: Social Security number
- 12: choose ‘ordinary passport’
- 13: your passport number
- 16: printed on your passport, usually ‘U.S. Department of State’
- 17: YOU are the applicant! Write in your home address, email, and telephone number.
- 18: complete only if applicable and if you’ve been issued any other visas in the past.
- 19: write ‘student’
- 20: choose ‘Studies’
- 21: give the date that you expect to arrive in Spain
- 22: choose ‘multiple entries’
- 23: For the Madrid program: Instituto Internacional, Miguel Angel 8, 28010 Madrid  
For the Valencia program: AIP Language Institute, c/El Bachiller, 7, 46010 Valencia  
Other programs: please complete with the proper address for your program.

**\*Please Keep in Mind\***

**Spanish Consulates CAN and DO change their policies and requirements suddenly and without notice.** We have created this document as a guide to help you, but it is YOUR responsibility to work directly with the Spanish Consulate to obtain your visa and to follow their most current procedures and requirements.

From past students' experiences, the best way to get a response from a Spanish Consulate tends to be through email or fax. Send your inquiry to the attention of: Student Visa Officer. Be sure to include your contact information including phone number in your letter.
