History, Culture and Politics of Cuba

A semester-long, 16-credit study abroad program in Cuba

Courses

370-570 (Pol Econ) Political Economy, 60 hours, 4 credits: Overview of Marxist political economy. Given the importance of Marxist thought in modern day Cuba, the first ten weeks offer a theoretical overview of Marxist political economy, focusing on the dialectic method, the theory of value, commodities, production, distribution and consumption, capitalist crisis, class formation, exploitation, hegemony, technological change, money and finance, the role of the State, and imperialism and colonialism. The final three weeks focus on the current political economy in Cuba, including an evaluation of the five economic eras since 1959 and the newly proposed economic reforms.

Course goals:

- Understand the basic Marxist analytical categories, including class, exploitation, value, crisis, and commodity.
- Understand the theoretical underpinnings of the Marxist critique of capitalism.
- Understand the dialectic method and historical materialism.
- Understand and evaluate the real life application of Marxism in Cuba.

371-571 (Hist) History of Cuba, 60 hours, 4 credits: Overview of Cuban history, including colonization, independence struggles, the 1959 revolution, the social impacts of the revolution, and the special period, with particular emphasis on US-Cuba relations as they developed through the centuries. Students will be able to situate an analysis of contemporary Cuba within an historical context. Workshops, meetings and museum visits compliment formal academic classes.

Course objectives:

- Understand the impact of colonization and slavery.
- Understand the historic cultural/political influence of the US on the island.
- Understand the development and meaning of nationalism.

- Understand the dynamics and impact of the 1959 revolution.
- Understand the stages of development of the revolution, with special focus on the economic, social and cultural changes.
- Understand the development and impact of the "special period."
- Understand and evaluate the economic and social changes announced during the 2011 Congress of the Communist Party.
- Understand the historic development of race and gender relations in Cuba.
- Understand the historic development of Cuban nationalism.
- Understand the impact of the Cuban revolution on second and third generation post-revolutionary Cubans.

373-573 (Pol Sci) Cuban Politics, 60 hours, 4 credits: Analysis of the Cuban State – how it is organized, how it functions, and the role of the Cuban Communist Party. The course includes a historic evaluation of US-Cuba relations and Cuba's international relations, as well as discussion of the role of Cuban society in politics and decision-making.

Course goals:

- Understand the ebbs and flows of US-Cuba relations, particularly as they relate to worldwide and regional political trends.

- Understand US policy initiatives toward Cuba and their impact on bilateral relations, including the embargo, the Torricelli Act, the Helms-Burton Law, TV and Radio Marti, and changes in travel restrictions, as well as the role of the Cuban-American community.
- Understand the context and impact of the October Crisis (aka, the Cuban Missile Crisis).
- Understand Cuba's international relations, with special focus on Latin America and Africa.
- Understand the structure and decision-making processes of the Cuban state, with special emphasis on the Cuban Communist Party and the various mass organizations (Federation of Cuban Women, Federation of Cuban Labor, Committees for the Defense of the Revolution)
- Critical evaluation of the impact of State-sponsored measures to alter race and gender dynamics after the revolution.
- Understand the role, scope of action and impacts of non-governmental organizations.

380 (Span) Spanish, 60 hours, 4 credits: Focus on conversational Spanish, reading and writing using popular education techniques. Readings and newspaper articles by Cuban authors, theater, music, and film provide

generative themes, which are used to create conversation and develop vocabulary and grammar. Weekly writing assignments of three pages in Spanish encourage students to reflect on the events of the week. Readings and generative themes are closely related to topics in other academic classes so that students develop intellectually in both Spanish and English. Students take an initial placement test to determine their level of instruction. Classes are small (generally 7 to 10 students) allowing for close personal attention.

- Manage vocabulary and grammar appropriate for academic discussions about other courses in the program.
- Improve verbal, reading and writing skills in a structured environment.
- Improve verbal communication skills in unstructured social environments.
