



#### SPAIN AND THE EUROPEAN UNION

**Area: International Relations** 

Instructor: Francisco Seijo

Francisco Seijo is a political science instructor at Middlebury College C.V. Starr School in Spain, NYU Global Campus Madrid and the Instituto de Empresa among others. He received his PhD in political science from Columbia University. Dr. Seijo's research focuses on environmental politics, forest policy, the politics of climate change and the politics of landscape fires (http://www.researchgate.net/profile/Francisco\_Seijo). His work has appeared in numerous scholarly publications as well as in the media. In addition to his academic activities Dr. Seijo has worked as a development consultant for various international governmental and non-governmental organizations.

### **Course Description**

The aim of the course is to introduce students to the history, the institutions and the politics and policies of the European Union (EU) with a particular emphasis on Spain's continuing role in this international governance regime. The first part explores the complex European setting and seeks to establish why the European integration process began, the theoretical - political and economic – underpinnings for its creation, and how and why the powers and membership of the EU have expanded and changed over time. The second part examines the history of the EU since its creation until the present while, in parallel, examining Spain's relationship with the EEC and, later, the EU. The third part looks at the institutional framework of the European Union and its main "pillars" for political and economic integration: monetary integration through the €, the Common Foreign and Security Policy (CFSP) and the Common Agricultural Policy (CAP). The course concludes by studying the most recent developments in the EU related to the crisis of the Eurozone and Brexit.

### **Learning Outcomes**

As result of taking this course, students will gain in-depth knowledge of the development and politics and policies of the EU. They will comprehend the nature of European integration, the process and outputs of EU policy-making, and the relationship between developments at member-state and European levels. In doing so, they will be able to compare the EU with other political systems and they will become

familiar with key theoretical debates surrounding the analysis of the EU. They will also develop key skills relating to the analysis of complex issues, the ability to produce papers and to participate constructively in group discussion.
